Age Limit : 35 to 65 years as on 01-05-2026. The upper age limit is relaxed able by six years in case of candidate Retire /Ex-Service man of Himachal Pradesh.

Application Fee: Rs.500/-. The fee should be paid through of Demand Draft only in favour of Chairman, SAMARTHYA FOUNDATION JAN KALYAN SANSTHA, Kullu payable at State Bank of India, Dhalpur Branch Kullu. The fee is non-refundable.

The above post is purely temporary and on honorary basis.

- (4) The candidate should not hold any post in Government/Semi Government/Autonomous bodies / Panchyati Raj Institutions/ Urban Local Bodies etc.
- (5) The candidate will be required to attend the office for at least four hours on every working day. He/ She will work as per job responsibilities assigned to him by the Controlling Authority.
- (6) The candidate will be engaged for one year, which may be extended on year-to-year basis subject to his/her performance.
- (7) The appointment shall not confer any right to the appointee for regularization of service/permanent absorption in Samarthya Foundation Jan Kalyan Sanstha, State Branch, Kullu at any stage.
- (8) After selection, the candidate shall sign an agreement. The appointee may leave the contract by giving one month notice.
- (9) The appointment is liable to be terminated in case the performance /conduct of appointee is not found satisfactory. Any sort of insubordination in discharge of duty.

(9) The appointee shall be entitled to 12 days casual leave during the calendar year excluding Sundays and other Gazette holidays but he / she will have to prior inform the Controlling Authority about his/her absence from workplace. No leave of any kind is admissible to the appointee.

(10) Unauthorized absence from the workplace without the approval of Controlling Authority shall automatically lead to the termination of the contract.

(11) The appointee will be entitled for TA/DA, if required to go on tour in connection with job responsibilities at the rates as approved /notified by the Chairman, SAMARTHYA FOUNDATION JAN KALYAN SANSTHA State Branch, Kullu.

(3) The candidate applying for the post should ensure that he/she fulfill all eligibility conditions as prescribed above. Incomplete application form will be rejected and no correspondence will be entertained.

(4) If on verification at any stage before or after the appointment, it is found that the candidate do not fulfill any eligibility conditions, his/her candidature/ appointment will be cancelled.
